### DIRECTIONS FOR USE

*Wear appropriate personal protection when using.*

**TOILETS BOWLS & URINALS: REMOVES HARD WATER DEPOSITS, RUST STAINS, AND OTHER STAINS.** 1. **MINT BOWL™** works more effectively when water is removed from the trap. This can be accomplished by using the bowl applicator or by pouring a bucket of water in the toilet. 2. Apply **MINT BOWL™** to the bowl swab (1-2 oz.). Swab up and around under the rim to clean and deodorize. **MINT BOWL™** can be squirted directly into the bowl if tough stains exist. 3. Let stand for 2 minutes and flush the toilet/urinal.

**CERAMIC TILE, PORCELAIN, SHOWER WALLS, FIBERGLASS: SCALE AND SOAP SCUM WILL INSTANTLY DISSOLVE AWAY.** 1. Vapors and mists are extremely corrosive to the nose, throat, and mucous membranes. Irritation, coughing, chest pain, and breathing difficulty may occur with brief exposure while prolonged exposure may result in more severe irritation.

**EMERGENCY AND FIRST AID PROCEDURES**

**INHALATION** - Remove to fresh air. **STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED**

For small spills dilute with water, mop or wipe up and contain. For large spills, contain by diking with absorbant material and carefully neutralize with lime. Keep material out of sewers, storm drains, surface waters, and soil.
