SCRUBBER™ works very effectively and efficiently in machines with recirculation capabilities. SCRUBBER™ contains special low foaming surfactants to control the foam in the recovery tank, filters and recirculation plumbing. This low foaming action allows the filters to perform at maximum efficiency. This performance extends the life of the cleaning solution and reduces the number a recovery tanks dumps. SCRUBBER™ does not contain harsh caustics or solvents and can safely be used on painted and coated surfaces. SCRUBBER™ will emulsify oily soil long enough to get the oil into the machine, but will release it in the reclaim cycle.

DIRECTIONS FOR USE

1. Dilute SCRUBBER™ in machine solution tank at the following:

LIGHT EVERYDAY SOIL - 1:20
 (6oz. per gallon of water)

MEDIUM SOIL - 1:10
 (12oz. per gallon of water)

HEAVY SOIL - 1:5
 (25oz. per gallon of water)

2. Run machine according to directions.

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED

For small spills dilute with water, mop or wipe up and contain. For large spills, contain by diking with absorbant material and carefully neutralize with a mild acid. Keep material out of sewers, storm drains, surface waters, and soil.

WASTE DISPOSAL METHOD

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING

Store in a dry, well ventilated place away from incompatible materials. Keep container tightly closed when not in use. Store at temperatures above the solutions freezing point to remain liquid. Do not use pressure to empty container.

OTHER PRECAUTIONS

Empty containers usually still hold residues of material and vapors. These must be considered hazardous and disposed of in accordance with proper handling procedures prescribed for hazardous chemicals. When mixing with water, always add this product to water and stir.
